Admission Regulations for International Applicants



Iran University of Science and Technology (IUST) proudly welcomes international applicants for admission to its Master's and Ph.D. programs.

Prospective students are required to thoroughly review the following terms and conditions and prepare all necessary documents before proceeding with their application.

Application Deadline for Fall 2025-2026: Tuesday, June 10, 2025

1- Document Submission

- **Dual citizenship** will result in immediate cancellation of registration.
- All documents (diplomas, transcripts, CV, recommendation letters) must be uploaded in **Persian or English**.
- Applications **without academic transcripts** will be deprioritized.

2- Tuition Fees (Per Semester)

- **Bachelor's:** €800
 - **Master's:** €1,000 (*€1,200 for Computer Engineering, English Language Teaching, Management, Economics, and Progress Engineering*)
 - **Ph.D.:** €1,200
 - **Payment Method:**
 - Fees are calculated based on the **official exchange rate** (<https://fxmarketrates.cbi.ir>) and must be paid **only via POS terminals**. Cash payments are **not accepted**.
 - Additional costs (housing, meals, insurance) are the student's responsibility.

3- Academic Requirements

- **Master's Applicants:** Minimum GPA of **14/20** (or 60/100) in Bachelor's.
 - **Ph.D. Applicants:** Minimum GPA of **14/20** in Bachelor's and **16/20** (or 70/100) in Master's.

4- Program Duration

- **Master's:** 2–3 years (4–6 semesters; thesis required).
 - **Ph.D.:** 3–4 years (6–8 semesters; research-based).

5- Interview

- Applicants may be required to attend an **in-person or online interview** as specified by the department.
-

6- Student Affairs Approval

- A "**No Objection Certificate**" from the **Student Affairs Organization** is mandatory before final registration.
 - **SAORG Code** must be obtained after receiving the preliminary acceptance letter.

7- Initial Admission Processing Fees:

The application submission, document review, and issuance of the preliminary acceptance letter are **completely free of charge**; no fees are required for these services.

8- Language Proficiency

- **Persian Language Certificate** (required for all programs).
 - **English Language Certificate** (mandatory for Ph.D.; conditional for Master's).
 - Non-compliant applicants must complete a **1-semester language course** before starting classes.

9- Required Documents for Final Registration

- Original passport.
 - Passport-sized photo.
 - **Authenticated** academic diplomas/transcripts (translated to English and verified by the Iranian embassy).

10- Additional Notes

- Admission is **capacity-based**; late applicants may lose priority.
 - Documents are scored by specialized committees based on **CV quality**.
 - Applicants **must attend administrative processes in person**.
 - **Fraudulent documents** will lead to immediate disqualification and disciplinary action.
